## 前言

1.01 我們於2010年9月21日設立申亞專題網頁及Facebook官方專頁，就「香港應否申辦2023年亞洲運動會」進行公眾諮詢。我們亦透過申亞專題網上討論區及「公共事務論壇」，搜集市民大眾對「香港應否申辦2023年亞洲運動會」的意見：

1.02 諮詢期結束時，申亞專題網上討論區共錄得超過19,000則留言，合共由約7,000位使用者發表，並有1,863人加入Facebook官方專頁；「公共事務論壇」約錄得150則留言，合共由約80位論壇成員發表。

1.03 網上留言如包含粗俗、辱罵、不雅、侵犯性、歧視或淫褻的言論或內容，或涉及商業廣告或宣傳資料，將會予以刪除，不會納入本附錄。

## 個人資料的處理

1.04 為保障個人私隱，申亞專題網上討論區、「公共事務論壇」和Facebook官方專頁的使用者若有提供個人資料，包括姓名、住址、電郵地址、身分證號碼、電話號碼、傳真號碼、年齡/出生年份、正就讀/曾就讀學校的名稱，以及現時/前僱主的名稱，我們均予刪除。

## 版權的處理

1.05 一些留言載有報章、書刊或網誌摘要。由於內容涉及版權問題，除非有關使用者已證明獲得出版人或版權持有人的書面同意，否則所涉的報章、書刊或網誌摘要一概不予列載。

## Foreword

1.01 On 21 September 2010, we launched a public consultation on “Should Hong Kong Bid to Host the 2023 Asian Games”. An official Asian Games website and Facebook page were set up and members of the public can express their views on the subject via the discussion room of the Asian Games website and the Public Affairs Forum.

1.02 At the end of the consultation period, we received over 19,000 messages from about 7,000 users in the discussion room of the Asian Games website, and 1,863 persons joined the fan page of the official Facebook page. For the Public Affairs Forum, some 150 messages were received from around 80 Forum members.

### Commercial lines and offensive languages

1.03 Any messages that contain vulgar, abusive, indecent, offensive, discriminatory or obscene comments or content, or commercial advertisement or promotion, would be deleted. These messages would not be included in this Appendix.

### Handling of personal data

1.04 In order to safeguard personal privacy, we removed personal data of those who commented on the discussion room of the Asian Games website, the Public Affairs Forum and the Facebook page, including user name, residential address, email address, Identity Card number, telephone number, fax number, age/year of birth, name of school attended/attending, and name of current/previous employer, where provided.

### Copyright handling

- 1.05 Some messages contained newspaper cuttings or extracts of books/magazines/blogs. As these articles involved copyright, they were not published unless the senders had shown that they had obtained written consent from the publisher or the copyright owner concerned.
